Who can participate?

The Trane Total Solutions Provider Program is available to, and benefits, all government entities that must comply with state procurement laws (public and private schools, colleges and universities, cities, counties, non-profits, hospitals, etc.)

How is the price established?

The price was established when the TCPN contract was awarded, which was based on the buying power of the potential membership.

How do I enroll in the Trane Total Solutions Provider Program?

First, you must join TCPN. Once a member, contact your local Trane representative listed on the TCPN website. The Trane representative will be happy to assist you in completing your purchase.

Must I bid purchases in excess of the state's minimum bid requirement?

No. TCPN awards contracts in accordance with state procurement laws, and entities utilize the work TCPN has done for you. Due diligence documents are available online.
