



OFFICIAL RULES

ELIGIBILITY: The Sweepstakes is open only to legal residents of the 50 United States, District of Columbia and Canada (except for Province of Quebec), 18 years of age or older at time of entry who are currently employed as Building Owners, Facility Managers, Contractors and Specifiers in the Non-Residential HVAC industry, and who received the email invitation to complete the survey. Individuals employed by or otherwise associated with Trane Technologies, Inc.
