

## Manufacturer's Tax Credit Certificate - Tax Payer Relief Act of 2012

The Tax Payer Relief Act of 2012 (25C) provides tax credits for the installation of Qualified Energy Property for residential heating and cooling equipment. Trane U.S. Inc. (Trane) certifies that the gas furnaces listed below meet the efficiency requirements of no less than 95% AFUE according to AHRI's rating system, and may be eligible for the Tax Payer Relief Act of 2012 if placed in service from January 1, 2012 through December 31, 2016.
