



**Manufacturer’s Tax Credit Certificate - Nonbusiness Energy Property Credit, IRC § 25C**

The Further Consolidated Appropriations Act, 2020 amended Internal Revenue Code section 25C, which provides tax credits for the installation of Qualified Energy Property for residential heating and cooling equipment meeting certain energy efficiency requirements. Trane U.S. Inc. (Trane) certifies that the gas furnaces listed below have an annual fuel utilization efficiency (AFUE) of no less than 95% according to AHRI’s rating system, and, therefore, may be eligible for the section 25C credit if placed in service by December 31, 2020.
